

# National Collegiate Honors Council Annual Business Meeting Swan & Dolphin Resort, Southern 2 Saturday, October 30, 2021

#### Call to Order: 8:04 a.m.

### V. <u>Treasurer's Report</u>

Keith Garbutt, NCHC Treasurer, acknowledged the organization's Executive Director, Mary Beth Rathe, and the NCHC staff for the outstanding job managing the organization's finances. Garbutt notified the membership that the organization had received the audit report for 2019. There were no findings in the 2019 audit. Obtaining a clean audit tells us that our management processes are in line with accepted good practices for accounting and management and legal requirements for the financial management of a nonprofit. Garbutt also noted this was the sixth clean audit in a row NCHC received.

In 2020 the organization saw a surplus of \$20,422, due mainly to the Federal Payroll Protection Program loan HEB and Rathe obtained during the pandemic. The loan allowed the organization to cover the payroll of all the NCHC staff during the pandemic without furloughs.

#### **Old Business**

#### a. 2021 Conference

Christina McIntyre, NCHC President-Elect, presented on the 2021 Orlando Conference. McIntyre spoke about the success of the in-person conference after a year of online programming. The organization met its attendance goals for the 2021 conference; however, attendance fail sharply from the 2019 conference,. McIntyre was delighted with the mix of speakers and the conference content the attendees presented. She closed by inviting everyone to join her in Dallas, Texas, for the 2022 conference.

#### b. 2022 Conference

Susan Dinan, NCHC Vice President, announced the Dallas conference theme concept of centering community. She thanked the staff and Julie Holm for all their work. Everyone should mark their calendar for the 2022 conference in Dallas from November 2 through November 6, 2022. Dinan announced a student service-learning project is being introduced as a signature program for the Dallas conference.

### **Presidential Address**

# A Sense of Belonging

I struggled with what to say in my presidential address. I wrote mostly about the issue that has been a core priority for me as president of NCHC. Our pursuit of Diversity and Inclusion in Honors and how much more we need to do. Last night it felt totally inadequate in view of the frank and heartfelt expressions about this issue I have been hearing from our students in the last few days.

So, I threw away my prepared talk and decided that the most genuine thing for me to say, on a topic I deeply care about and struggle with but don't have answers to, is to share with my Honors colleagues and students, my personal experience as a person of color and an immigrant.

Describing myself with these qualifiers to academic colleagues is something I have never done and feels odd to me because one's otherness is not fashionable to talk about professionally. At the same time, it feels cathartic.

I am a privileged person of color. Though I arrived in the US, over 40 years ago with a suitcase and \$8, I also had a scholarship to pursue a PhD at Princeton and I had the best mentors and professors in the field of Astrophysics at my program. The privilege I enjoyed and continue to enjoy is genuine.

More recently though I have come to realize that the gratitude I feel for my privilege resulted in rationalizing and explaining away prejudiced and bullying behavior that hindered or demeaned me.
